Who's Responsible for Sidewalks?

It depends. Different people have different responsibilities.

Sidewalks are great except when someone trips or slips and falls because of a sidewalk issue. That's when the injured party sues the association and our liability premiums rise. (Also, don't forget that the injured party was injured, which shouldn't happen to anyone.)

Property owners and Orange County are each responsible for sidewalks, not the HOA. Orange County is responsible for new sidewalks and sidewalk repairs for safety concerns.

Property owners are responsible for keeping sidewalks clean and (especially) free of slimy, slippery buildups, so nobody slips and falls. Owners are also responsible for reporting any trip hazards such as

sections that are pushed up by roots of nearby trees. If a section is raised more than an inch higher than the next section, report the problem to Orange County by calling 311 on your cell phone or dialing (407) 836-3111 on your landline.



Dinged by WLCA? It's Not Us!


In August 2022, Waterford Lakes Community Association (WLCA) mailed a letter to each homeowner announcing & describing their new Community Standards Department, (CSD) and the reasons for its existence. A similar announcement was posted on their website (https://wlca.nabrnetwork.com/communityfeed.php) on October 7, 2022-- "Introducing Our Compliance Coordinators", just before they began their community-wide inspections.

Many of you received violation letters from the new WLCA CSD inspectors. Many of you are unhappy with those letters. And so are we. With a few exceptions, Cypress Isles has been one of the best-looking and well-maintained neighborhoods in all of Waterford Lakes. A lot of the neighborhoods can't make that claim, mostly due to lack of volunteer involvement, including little or no active neighborhood Board of Directors, or poor management. Our CI managers & directors have had mostly positive results with our violation letters. There are, of course, those few who ignore the violation letters until legal action is taken. With the new system, they become WLCA's problem.

Moving forward, our Board of Directors will be working closely with the WLCA CSD to try to reach some agreement for following our Cypress Isles policies for violations, which are not always 100% in sync with WLCA's policies. In the meantime, if you receive a letter from WLCA and have an issue with it, please send an email to ARA@mywaterfordlakes.org. You can also send your concerns to that address if you see a bad-looking property in any Waterford Lakes neighborhood that never seems to improve or is not maintained on a regular basis.

Cypress Isles Assessment Increase 0.9% in 2023

But WLCA assessments will go up 6 %.





On September 20th the Cypress Isles Board of Directors approved a \$30,240 operating budget for 2023 with homeowner assessments of \$54.00 per quarter, a 0.9% increase from 2022. 'The operating budget is shown on some other page and posted on the Cypress Isles website.

In a related story, the WLCA Board of Directors approved a \$3.1 million operating budget with homeowner assessments of \$250 per quarter in 2023. The multi-page WLCA budget is posted on the WLCA website, available to all residents at http://www.mywaterfordlakes.org [resident login] Resources > Waterford Lakes Documents > Financial Documents > Waterford Lakes Budget.

The 2023 WLCA assessment represents a 6.04% increase over 2022 and is largely due to increased personnel expenses in the newly established Community Standards Department.

To complete the comparisons, neither the WLCA nor Cypress Isles increases are as large as the 8.2% general inflation rate or the 8.7% increase in the Cost of Living Allowance (C.O.L.A.)

Water Restrictions

No, they haven't gone away...

This article is a rerun for the benefit of new neighbors who may not know this info, and for some of us old-timers who may forget! ©



We are still under the same Orange County mandatory water restrictions that were implemented in 2008. As a reminder of what that means:

- Water only if necessary and not between 10:00 a.m. and 4:00 p.m.
- Water in accordance with the following irrigation schedule:

Time of year	Homes with odd-numbered addresses	Homes with even-numbered addresses
Standard Time November 6, 2022 to March 11, 2023	Saturday only	Sunday only
Daylight Saving Time March 12, 2023 to November 5, 2023	Wednesday & Saturday	Thursday & Sunday

BOTTOM LINE:

NO WATERING on Monday, Tuesday, and Friday.

NO WATERING between 10:00 a.m. and 4:00 p.m. on your designated day, or ANY day.

Odd numbered houses may water on Saturday all year, and also on Wednesday during Daylight Saving Time (March 12 – November 5, 2023)

Even numbered houses may water on Sunday all year, and also on Thursday during Daylight Saving Time (March 12 – November 5, 2023).

The exceptions to these rules are newly planted sod (30 days); and "watering in" fertilizer or chemicals within 24 hours of application, but still not between 10 a.m. and 4 p.m.
